



200hr Y4Y Yoga Teacher Training Program Cancellation & Refund Policy/ Buyer's Right to Cancel

- Applicants will be notified of acceptance/rejection via an email
- A \$300 deposit must be included with registration to be considered.
- To Cancel, students must fill out and submit the “Notice of Cancellation” form located on following page. A written, signed and dated notice of withdrawal is required. Emailed notices must be signed, scanned and sent. Typed signatures will not be accepted.

The student will receive a refund of money paid per the schedule below.

- If your application is rejected, you will receive a full refund of all tuition including deposit.
- If you give notice that you are cancelling your contract within five business days after the contract or enrollment agreement is considered effective you will receive a full refund of all tuition including deposit. A contract or enrollment agreement will be presumed to be effective on the date that institution notifies you that you have been accepted into the training and you have signed the contract or enrollment agreement. If the notification of acceptance into the institution is sent by mail, then the effective day of being accepted is the postmark on the acceptance letter. This 5-day refund policy applies regardless of when the program starts.
- If you give notice more than five days after you signed the contract, but before the start of the program, you will receive a refund of all tuition, fees and other charges minus your \$300 deposit.
- If you give notice of your withdrawal after your program has begun, but before 75% of the program has been completed, you will receive a prorated portion of the tuition, fees and other charges minus a \$50 administrative fee.
- If you give notice of your withdrawal after 75% of the program has been completed, you are not entitled to any type of refund.

You will receive a written notice acknowledging your withdraw request within 10 business days after receipt of the notice and you will receive a refund of any tuition within 30 business days of receipt of your withdrawal. Written notice is effective of the date of the postmark if sent by mail or the day it was hand-delivered or emailed to the institution.

If you do not withdraw in writing or contact the institution about your absence, and you have not attended your program for 21 consecutive days, you will be considered to have withdrawn from the school as of your last date of attendance.
